A follow up meeting on the Innovation Fund granted to Mawtneng village was held on the 16.09.2020. It was noted that under the Headmanship of Mr. A.G.Sten, the Innovations fund is being implemented by three squads or committees A. The Biodiversity Squad led by Mr. Wording Sohiong (Biodiversity Squad Leader) looked into the propagation of the different species of flora and fauna. For this purpose they have constructed:

- . Amphibian Habitat (
 tortoise,Frogs,Dragonfly etc),
- ii. Aquatic Habitat for endangered and local fish species
- iii. A nursery for endangered tree species.

- The propagation and cultivation of the "la Met" to replace the usage of plastic making it a plastic free village.
