4. Quotation Price

- a) The quantity offered should be 100% of the requirement for the whole package. Corrections, if any, shall be made by crossing out, initialling, dating and re writing.
- b) All duties, taxes and other levies payable on the raw materials and components shall be included in the total price.
- c) Goods and Service Tax (GST) should be indicated separately.

- **8. Evaluation of Quotations:** The Purchaser will evaluate and compare the quotations for the whole package that are determined to be substantially responsive i.e. which
 - (a) are properly signed; and
 - (b) Confirm to the terms and conditions and specifications.
 - (c) The Quotations would be evaluated lot wise; GST will not be taken into consideration while evaluating the quotations.
 - (d) Any historical information, if required may be asked from the bidders during evaluation of quotes.
- 9. **Award of contract:** The Purchaser will award the supply order to the bidder whose quotation has been determined to be substantially responsive and who has offered the lowest evaluated quotation price for that respective lot. The announcement for this assignment will be published in www.cllmp.com and www.mbda.gov.in
 - Notwithstanding the above, the Purchaser reserves the right to accept or reject any
 quotations and to cancel the bidding process and reject all quotations at any time prior

- to the award of contract. The numbers against each item may increase or decrease at the time of issuing the Purchase Order.
- b. The bidder whose quotation is accepted will be notified of the issue of Supply Order by the Purchaser prior to expiration of the quotation validity period. The terms of the accepted offer shall be incorporated in the supply order (sample form attached).
- 9. Payment shall be made with 60 days after delivery of the goods.
- 10. Normal commercial warranty/ guarantee shall be applicable to the supplied goods.
