- **8. Evaluation of Quotations:** The Purchaser will evaluate and compare the quotations that are determined to be substantially responsive i.e. which
 - (a) are properly signed; and

 - (c) The Quotations would be evaluated for the items listed; GST will not be taken into consideration while evaluating the quotations.
- **9. Award of contract:** The Purchaser will award the supply orders to the bidders whose quotations have been determined to be substantially responsive and who has offered the lowest evaluated quotation price for that respective lot.
