A meeting was held at Nongtnger hall, Nongjri to discuss technical inputs on OLC as well as to meet the VECs members and community members from five non-CLLMP villages under Ranikor C&RD Block. The purpose of the meeting was to discuss the land reclamation of mine spoilt areas. The participants re-visited the OLC site and witnessed field demonstrations on OLC in all five villages. The progress of land treatment activities was also discussed during the meeting.

EE-Social Management and M&E visited Domjyrti VNRMC to review records of minute book, training records, purchase register and M&E data related to procurement.



AM and EE Social Management attended two-day KYAN training program held at Nativity Higher Secondary School (Mawkyrwat).

**East Khasi Hills**



The monitoring and evaluation team conducted a visit to Rngi Myllem on March 16, 2023, to evaluate both completed and ongoing activities. The VNRMC members were present during the assessment. Subsequently, the team had a meeting with the secretary and VCF at the VNRMC Level of Rngi Myllem. It was observed that the seed bank established under the Myllem Block has been successfully completed at Rngi Myllem.



Seed ball preparation training was provided to 46 schools in the Mawryngkneng block by the training specialist and environmental team. The training received a positive response, with active participation from all attendees.



The monitoring and evaluation team, along with the VCF from the VNRMC, conducted a site inspection on the ongoing Community Nursery and Spring Chamber projects, as well as the ongoing FMP activities at Mawnainglah under Myllem Block.

The KM team visited Mawkynew village to gather stories from the villagers and inform them about the upcoming video documentation that would focus on CLLMP interventions in the village.



On March 22, the KYAN community training for schools was conducted at MIIT Shillong, with the participation of school teachers from both Myllem and Laitkroh blocks.



The Monitoring and Evaluation EKH team visited three VNRMCs located in Mawsynram Block, namely Nongdommawria, Pongkung, and Kpermasi to monitor the physical progress of all the implemented activities, including Spring Chamber, Loose Boulder, Afforestation, Check Dam, Erosion Protection Wall.

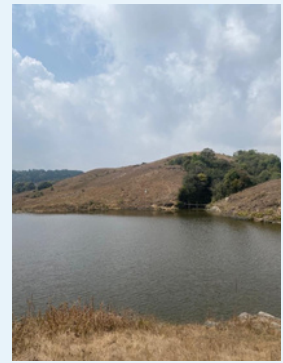

**DISTRICT WISE ACTIVITIES**



The environment team and training specialists conducted seed ball training sessions in six locations falling under the Mawryngkneng block. Out of the 29 schools in the area, 26 showed up for the training, which was led by 10 different Master Trainers.



The EKH DPMU conducted a field visit to Mawkynew Village to document and highlight the key achievements of the CLLMP interventions. The team focused on a site located in Mawkynew Village called "Mawnongpluh" where most of the major activities were implemented, including Staggered Trenches (5000 nos), Gully Plug, Afforestation (15,000 nos planted), Peripheral Bunding, Contour Bunding, Fire-Line Control, Erosion Protection Wall, Bench Terracing, and Water Reservoir-Dam.

The DPMU EKH conducted monitoring and evaluation assessment in three locations, namely Iewrynghep, Umkhoi, and Mawlyngot, all of which fall under the Mawkynew block on both ongoing and completed CNRMP activities. This was followed by a meeting with community members to focus on the deadline for completion of all pending activities. Additionally, the VNRMC from Mawkynew Block visited for process monitoring and evaluation.

**North Garo Hills**



A visit was made to Ronggopgre and Rongjal VNRMC to collect data for the FMP and update the village report. Additionally, photos were taken at Ronggopgre and Rongjal VNRMC, and a site visit was conducted at Ronggopgre Fish Sanctuary.

During the visit, it was observed that the youth club of the village was constructing a sitting shed using the funds received from the Best Natural Resource Management Award in 2022 through the CLLMP project, and the construction was still ongoing.



A visit cum inspection was conducted at Baralipara VNRMC to review the progress of the ongoing activities related to FMP, permanent community nursery, and maintenance work required at a specific site. Additionally, the utilization certificate of VNRMC was also verified during the visit.



Two-day training session was held for the VCFs (Village Community Facilitators) MegLIFE Villages at the Kharkutta Community Hall in Kharkutta C&RD Block. The training focused on Sloping Agriculture Land Technology and covered topics such as Soil and Water conservation, Vegetative diversity, Soil health and fertility management, and SALT Farm Management. In addition, the farmers were taken on an exposure visit to demonstrate farming techniques.

## PAYMENT FOR ECOSYSTEM SERVICES



In an awareness program in the village of Mawlyndun under Pynursla block, participants showed keen interest in the Payment for Ecosystem Services scheme. It was observed that the forests in the area are primarily utilized for broomstick cultivation, and some forest lands are less than two hectares in size.

An awareness program was conducted in the village of Wahumlein, situated in the Pynursla block. Despite the fact that all the participants showed interest, it was observed that most of their forest lands were being utilized for betel nut cultivation.



GFA, Smarthe G. Momin visited the forest owners in Gambaregre village under Rongram Block, who have two forested areas and expressed their interest in applying for the scheme.



An awareness program was held at Laitnamlang village, under Mawthadraishan block by GFA, Shemborlang Ryntathing. The villagers showed interest in the scheme, and five of them have decided to apply. They will be submitting their application forms next week.

An awareness program was conducted at Shiliangjashar village, under Pynursla block. The village has its own forest, and the headman expressed his interest in applying for the scheme. However, before doing so, he plans to hold an EC (Executive Committee) meeting with all the members of the village to discuss and decide upon the matter.

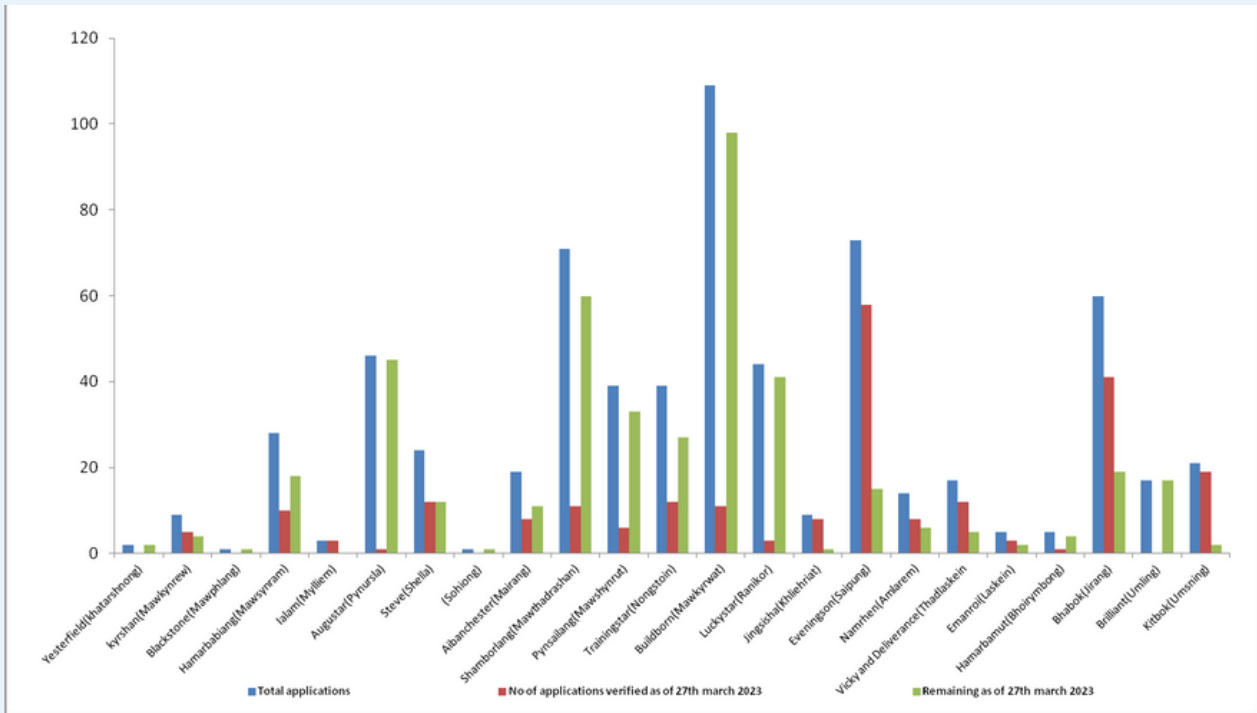

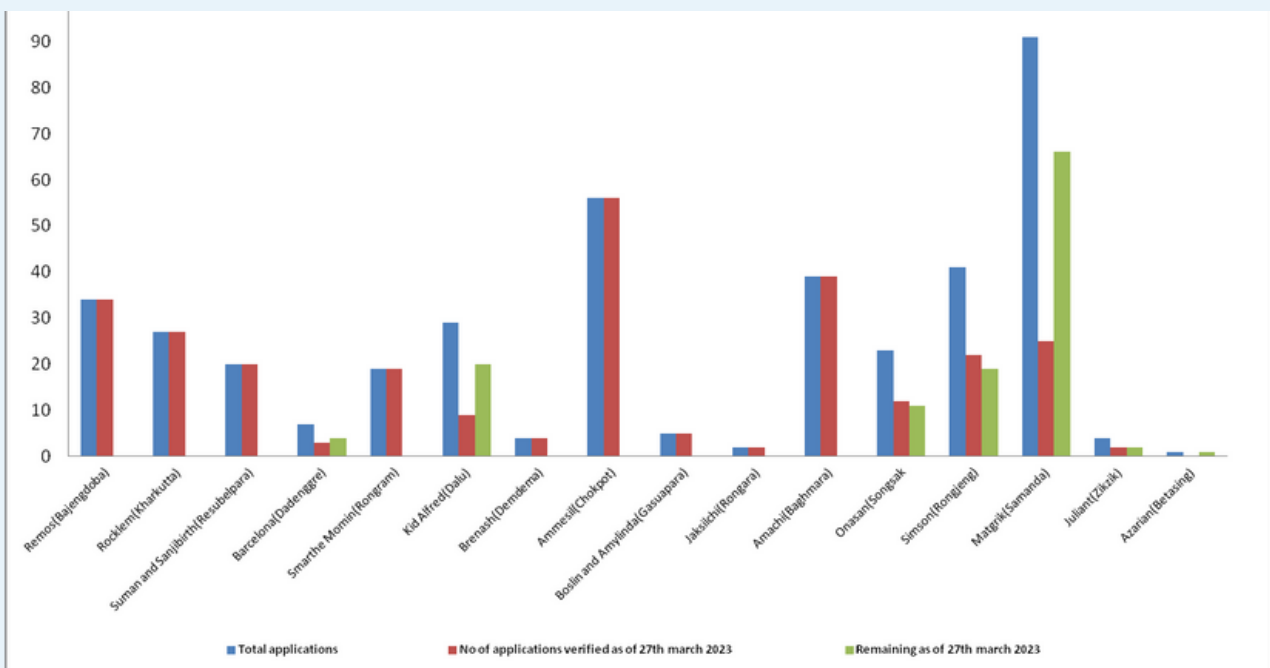

For the **Khasi - Jaintia Region** the number of applications received in Phase (2 batch 1) is 656, of which total verification/boundary mapping completed by VCF's/GFA's is 245 and remaining applications to be verified is 411 (as of 27th March 2023).



For the **Garo Region** the number of applications received in Phase (2 batch 1) is 403, of which total verification/boundary mapping completed by VCF's/GFA's is 291 and remaining to be verified is 112 (as of 27th March 2023).

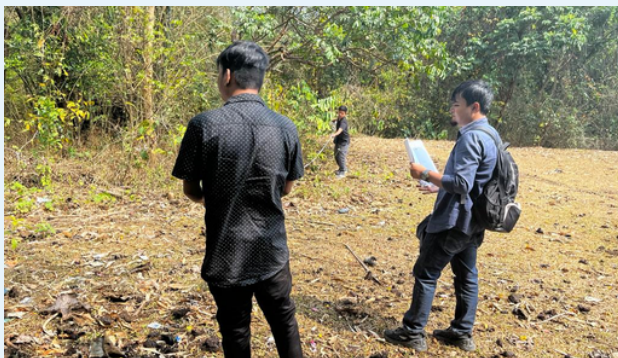

# SUCCESS STORY



## KONG TRINTIMAI'S STORY

Kong Trintimai Lyngkhoi resides in Mawphanlur village and relies entirely on agriculture for a living. She has a strong passion for cultivating medicinal plants, but due to a lack of resources and knowledge, she faced challenges in starting her venture.

The Megh Aroma Mission stepped in to help Kong Trintimai Lyngkhoi achieve her goal. This organization is dedicated to encouraging the growth of medicinal and aromatic plants in Meghalaya. In 2019, Kong Trintimai attended an informative session organized by the Megh Aroma Mission, which focused on the cultivation of medicinal and aromatic plants (MAPs). During this event, Kong Trintimai expressed her desire to cultivate these plants. Recognizing her potential, the team provided her with training and assistance to help her get started.

The cultivation of geraniums is widely regarded as a difficult task due to their susceptibility to pests and diseases, as well as their environmental requirements, which include well-draining soil, regular watering, and ample sunlight. Growing geraniums necessitates a significant investment of time and effort. Regular pruning, deadheading, and fertilization are critical for their proper growth, which can be labor-intensive, particularly on a large scale.



Kong Trintimai Lyngkhoi's persistence and eagerness to learn during her training allowed her to overcome the challenges associated with growing geraniums. With the Megh Aroma team's guidance, she gained knowledge on caring for the plants, using organic fertilizers and pesticides, and harvesting them correctly. Initially, she received only 300 geranium saplings from the Mission, but her hard work and dedication paid off as she successfully cultivated over 5000 geranium saplings with excellence. Additionally, she expanded her pursuits by cultivating lavender, another profitable crop. In addition to growing medicinal and aromatic plants, she generates extra income by keeping bees and selling their honey.

Thanks to her success, Kong Trintimai Lyngkhoi can now offer geranium saplings to other villagers and Self Help Groups who are interested in cultivating them. The Megh Aroma Mission has also taken steps to promote geranium cultivation in the region by providing training on its cultivation and facilitating the transfer of 2000 geranium saplings from Kong Trintimai to two Self Help Groups in Mawthapdah village, South West Khasi Hills district.

To encourage entrepreneurship and maximize the potential of medicinal and aromatic plants, the Megh Aroma Mission provided Kong Trintimai with 50 litres of Field Distillation Units. These units can extract essential oils, which can be utilized for marketing purposes. Geranium oil is mainly used in perfumery and cosmetic industries. It is also used as agrochemicals against insect pests, antimicrobial and antistress oil.

Kong Trintimai Lyngkhoi's accomplishments in agriculture have made her a role model for other aspiring farmers in her community. Her success story serves as a testament to the transformative impact of hard work, dedication, and support.

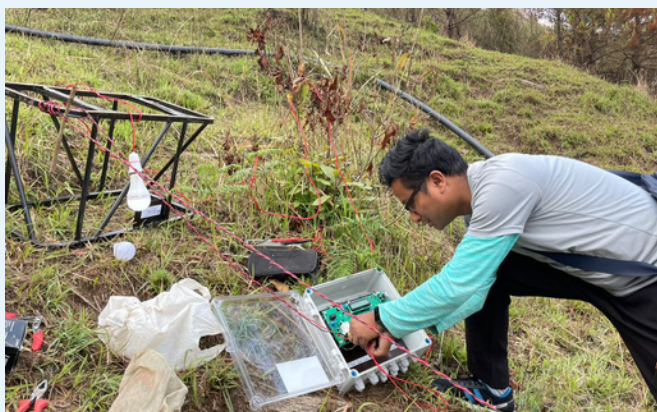

## MEGHALAYA LIVELIHOODS AND ACCESS TO MARKETS PROJECT

From March 22nd to March 25th, 2023, the Business Facilitator of Santipur IVCS organized a four-day training program to promote financial literacy among the members of IVCS.
