On April 18th, 2023, a joint inspection program was carried out by APO and Technical Assistant from Myllichem Block to monitor the progress of the implementation of Catalytic Funds by the VECs. During the inspection, the following VECs were visited: Ponkaniew, Liewlong, and Myllichem Mawiong. The VECs had implemented projects such as Water Harvesting, Irrigation Canal, Check Dam, and Spring Chamber, all of which were successfully completed. Furthermore, the VECs had submitted Utilization Certificates for all the activities as well.



On April 18th, 2023, the EKH GIS team conducted a survey and map-making exercise for the Land Use Zonation Map, Forest Condition Map, Ownership Map, Intervention Map, and Transect Walk as part of the Micro Plan and PLUP of the Meg LIFE project. The survey and map-making exercise took place in Mynsang Village, Mawkyntsew Block.

On April 19th, 2023, the field engineers of DPMU-EKH visited Laitsohphlang VNRMC in Mawphlang Block to inspect the progress of the protection wall being constructed using funds from CNRMP.



The EKH Environment Team and the Training Specialist, along with the VCFs, have kicked off the second phase of Seed Ball Training in Shella Bholaganj Block. They successfully trained 38 out of the 40 schools scheduled to participate on April 20th, 2023. The enthusiasm for dispersing seed balls was contagious, and we hope to see the positive impact this initiative will have on the environment.



On April 19th, 2023, the field engineers of DPMU-EKH went to Laitsohphlang VNRMC in the Mawphlang Block to conduct a follow-up inspection of the completed Fireline control project, which was implemented using funds from FMP.

## The Antidote (Ka Ladew) - Sohkhylam VNRMC

Sohkhylam is a village in the South West Khasi Hills District that is part of the Mawkyrwat C&RD Block. It is home to 723 residents in 128 households and covers a geographical area of 194.97Ha. The village is approximately 3km away from the district headquarters in Mawkyrwat. Most of the people living in Sohkhylam are involved in agriculture, but there are also teachers, businessmen, and government workers among them. There are two primary schools and one secondary school in the village, and Mawkyrwat CHC, the district headquarters, is the nearest healthcare center. In addition to the VNRMC of CLLMP, Sohkhylam has its own village executive members.

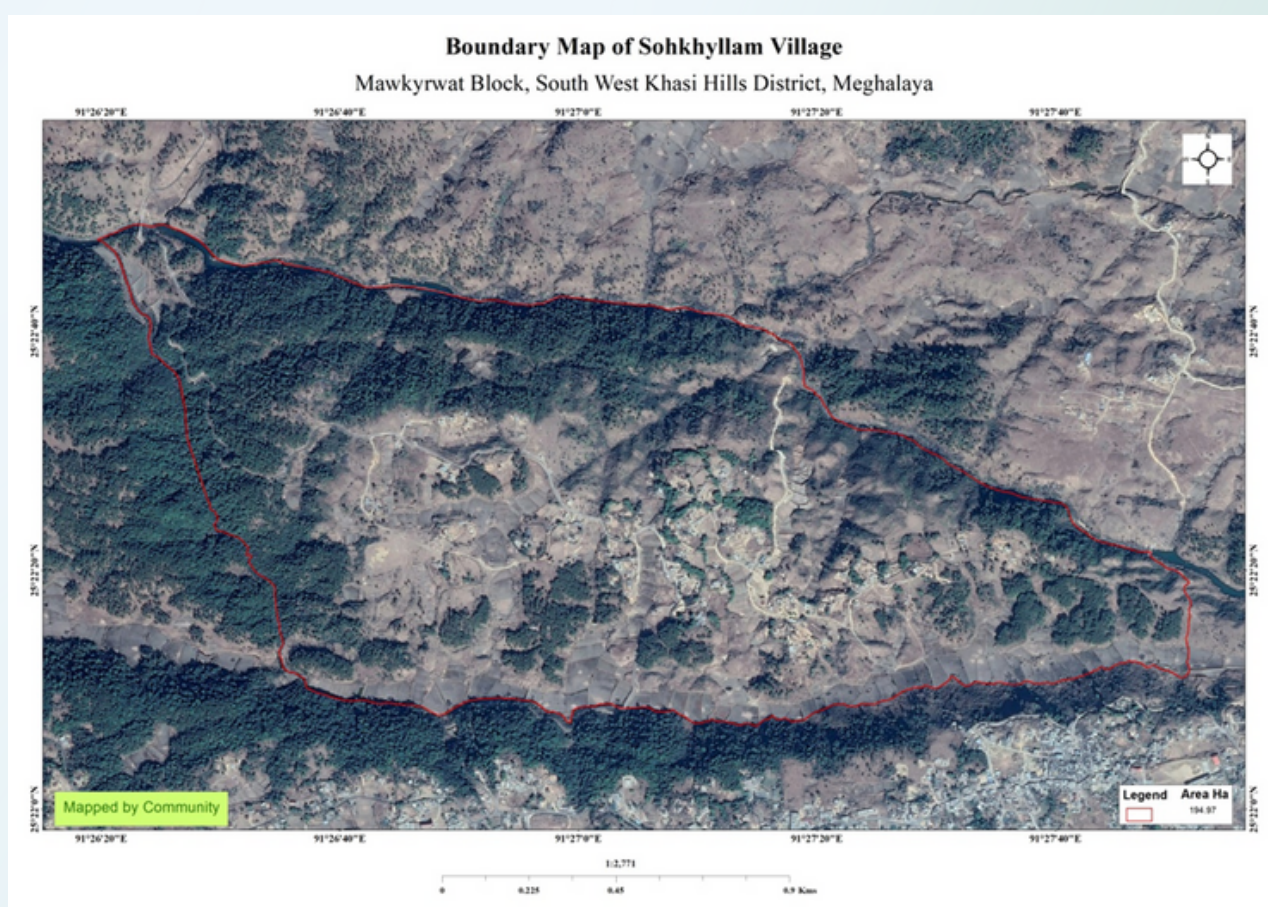


Fig: Boundary Map of Sohkhylam Village

The village of Sohkhylam has many streams as well as a big river named Wah Sala or Phot Sala that flows through the village's border. The community has always conserved and preserved this free-flowing river, which has been a wonderful blessing to them because it is home to many of the local fish species. During the fish breeding season, many children and adults, both men and women, would fish from it as a hobby.

However, the youth of Sohkhylam recently found out that some people from nearby villages frequently come during the night to poison the fish in the nearby waters with something called "tutiya," which is also known as bluestone or copper sulphate. This chemical is actually a fungicide that is used to kill several fungi. Nevertheless, due to their selfishness and greed, individuals began to abuse and misuse this substance, using a net to poison fish and only catching those that later floated to the surface of the river. Whenever this happens, the locals immediately start looking in their village or nearby villages for a banana tree trunk to place it on the poisoned river, as taught by their ancestors. This is because the banana stem has great water retention ability, which would neutralize the water.

To address this problem, the Seng samla shnong put together a group to volunteer to check for any outsiders who are attempting to poison the river, and those found doing so would be charged a heavy fine.

One of the activities proposed by the youth members of the VNRMC is to plant banana trees along the banks of the Phot Sala River. Banana trees are known to have great water retention abilities, and in the future, this would make it easier for the youth members to find access to banana stems within the village. This property of the tree and its benefits prove the science behind the knowledge passed down from past generations. Starting from the last week of July 2022, six youth members of Sohkyllam planted 300 indigenous banana plants along a 1km stretch of the Phot Sala River. They cleared the area and dug pits measuring 0.30m x 0.30m, filled them with cow dung, and planted the saplings. The VNRMC employs youths from the village to care for the rivers and check for outsiders, as this would encourage them to safeguard the rivers and provide additional income. The VNRMC expresses their gratitude to the World Bank and CLLMP for their support and guidance throughout this intervention and hopes that this plantation will be a success.

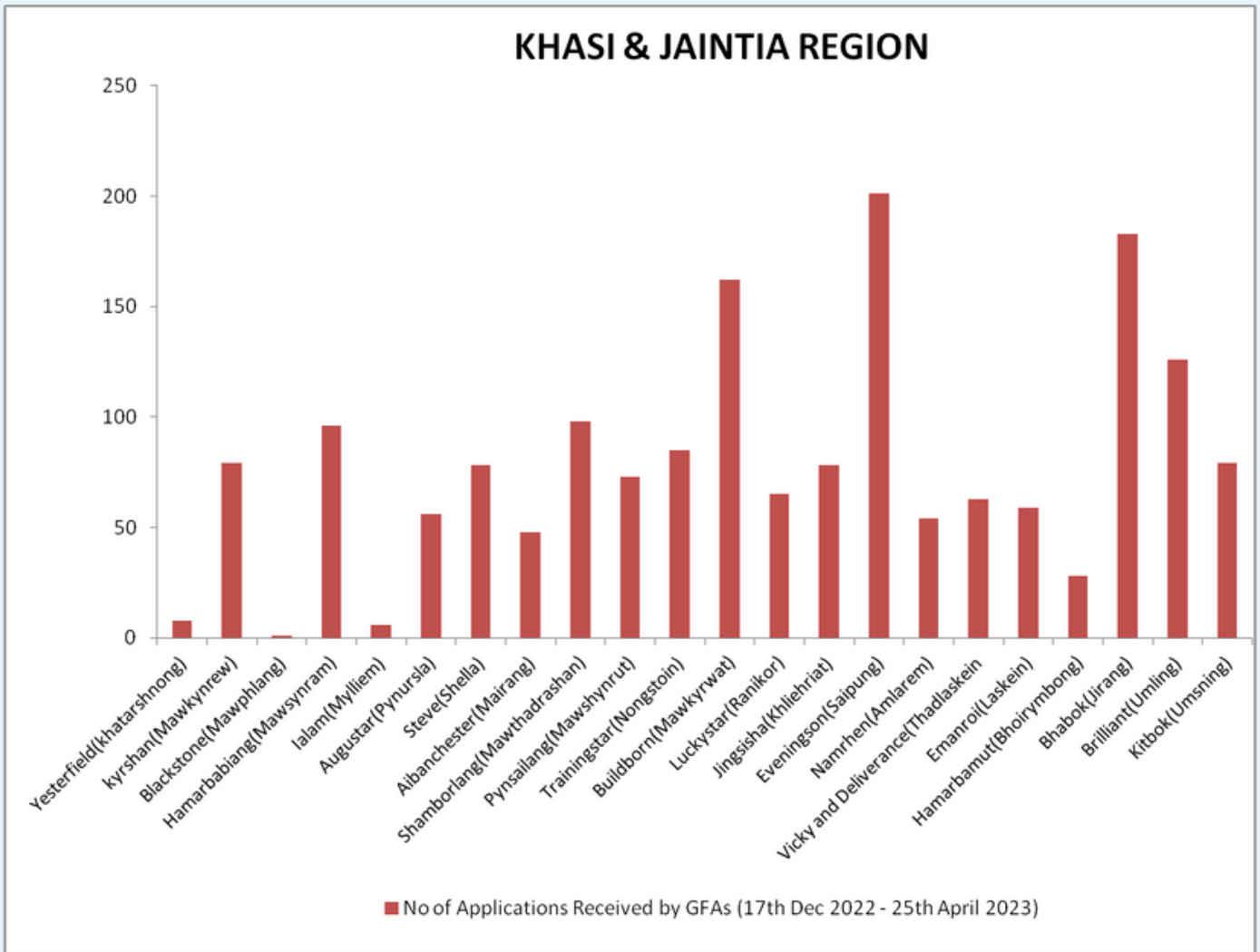

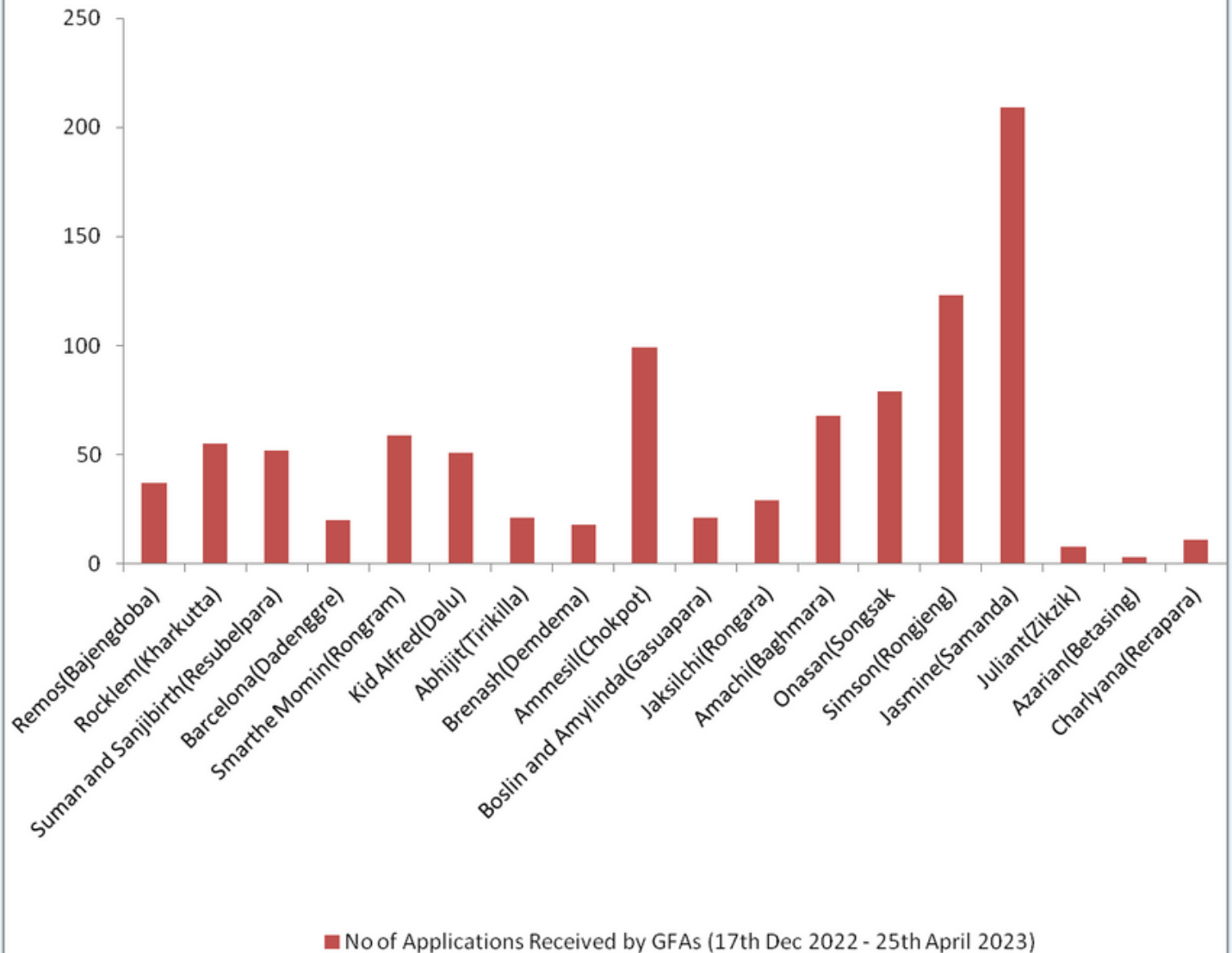

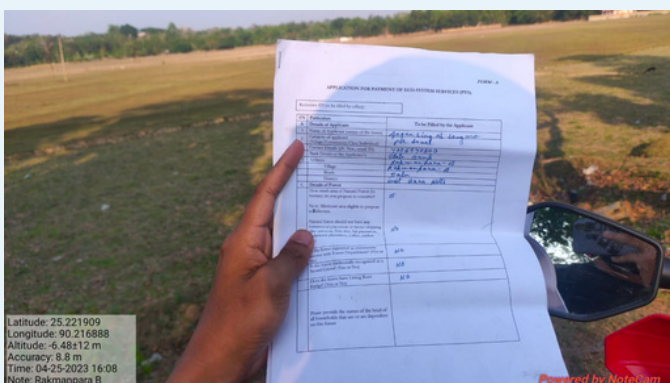

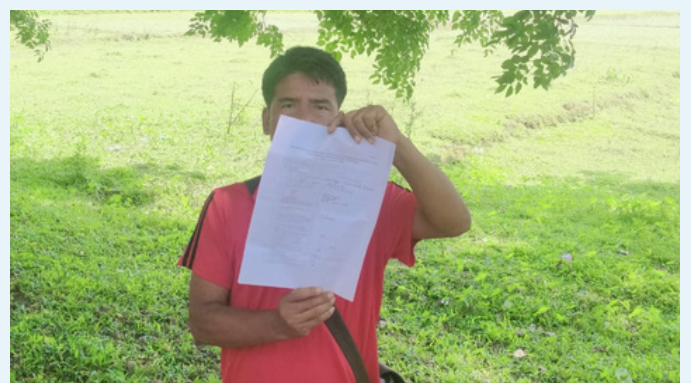

**MEGHALAYA LIVELIHOOD IMPROVEMENT THROUGH FOREST ENHANCEMENT (MegLIFE)**

SALT Consultant, David Gandhi, visited Gitokgre village in the Samanda block of EGH on April 21, 2023, to meet with the SALT farmers and evaluate their preparations. Notably, all five farmers were women, and the VCF had assisted them by constructing the A-frame using wood.



During his visit, Mr Gandhi also engaged with the KM and Drone teams, who were present for video documentation purpose. It was delightful for him to witness how the village children were fascinated by the drones.

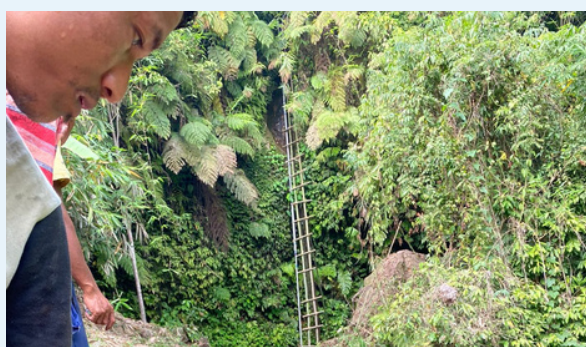

# MEGHALAYA LIVELIHOODS AND ACCESS TO MARKETS PROJECT

## COLLABORATION IS KEY

ISC&ED, INRM and Rural Finance Collaborates to Achieve Project Goals



On April 19th, 2023, a site inspection was conducted in Jabar Lumtop Jaud, Sohiong Block, East Khasi Hills to assess its suitability for a potential multipurpose nursery and field demonstration plot. This inspection is part of an integrated approach of the INRM and ISC components



On April 18th, 2023, officials from NRM, ISC & ED, and the MC Member of Diengkynthong IVCS under Khatarshnong Laitkroh Block, EKH, met to discuss the procurement process for machineries to be used in the Honey Processing Unit to be established in Diengkynthong Village. The meeting also covered other procurement processes to be undertaken under NRM and ISC & ED components.

## MEGHALAYA LIVELIHOODS AND ACCESS TO MARKETS PROJECT



A one-day workshop was held on April 13th, 2023, at the DPMU Office in Mawkyrwat. The workshop featured resource persons from the Rural Finance Team, who were briefed and assigned to assist with the books of accounts for the CMC, CHC, and FPC under the Ranikor C&RD Block.



On April 20th, 2023, the MLAMP committee members conducted site inspections in Pyndenglitha and Kyiem villages, in Mawphlang Block. The purpose of the inspections was to select a suitable field demo plot for Open Pollinated Seeds (OPS), Farmers Field School (FFS), and a Multi-Purpose Nursery Unit under the INRM program with ISC and ED components

## MEGHALAYA LIVELIHOODS AND ACCESS TO MARKETS PROJECT



On April 20th, 2023, a community-level meeting was held at Gairong village, Kharkutta C&RD Block, under Nangrime IVCS. Traditional heads of 14 villages, elders, market committee members, IVCS management committees, and DPMU staff of North Garo Hills were present. Attendees were informed about various MBDA-MBMA interventions under the MLAMP project and FOCUS. The meeting concluded with a decision to encourage rural households to participate in IVCS and other programs, including marketing of produce. The newly constructed ginger processing unit, cold storage, and PRIME Rural Hub within the Gairong area were also introduced.



On April 12th, 2023, a joint survey was conducted during a consultative meeting with Upper Kharkutta IVCS Ltd and Kharkutta Market Committee, and Nangrime IVCS Ltd and Gairong Market Committee. The survey revealed incomplete construction of market sheds, causing delays in the allotment process and handover for marketing purposes.

## MEGHALAYA LIVELIHOODS AND ACCESS TO MARKETS PROJECT

### ISC & ED



MeghaLAMP, in collaboration with Trifed, India, expanded its outreach to West Jaintia district after successfully hosting the Tribal Artisan Mela in East Khasi Hills District. The event was held in Jowai on April 21st-22nd, 2023, where seven out of twelve artisans were empanelled, and 28 samples were purchased, amounting to Rs. 11,440. This expansion into the West Jaintia district is a significant development for the artisans of the region, providing them with access to a larger market and better prices for their products. In addition, the DPMU of West Khasi Hills collaborated with Trifed to organize a Tribal Artisan Mela on April 24th-25th, 2023, where 16 artisans were empanelled, 12 were identified for training, and 57 samples were purchased amounting to Rs. 18630, further boosting the outreach of the program and supporting the rural artisans of the region.

## ISC & ED



Training on potato seed production ARC (Apical Root Culture) was conducted at Umsawmat and Lawkhla Mawlong villages, Mawphlang C&RD Block, East Khasi Hills, as part of the Seed Secure Meghalaya initiative in collaboration with FOCUS Producer’s Group. The training included sensitization and hands-on sessions.



On April 19th, 2023, a sensitization programme on data collection was conducted for Group Facilitators and CMC Facilitators at EFC Ranikor C&RD.

**GENDER**



A digital literacy training program was held from 17th to 21st April 2023, for women from Ri Bhoi District (Umling C&RD Block) at MATI Shillong. The program aimed to empower the participants by providing them with basic computer knowledge, covering topics such as computer operations, word processing, spreadsheet usage, presentation making, internet introduction, electronic mail, Meghalaya e-district services, digital payments, and cyber safety. The program had 17 participants selected from IVCS & PG members class 10 onwards.
