DISTRICT WISE ACTIVITIES







On May 22, 2023, the DPMU team visited Rongdenggre Village in the Rongram Block for a joint inspection of multiple sites. They evaluated the permanent nursery at Wage, inspected the PCC water reservoir at Anu Bisik, assessed the condition of the old community nursery at Wage, examined the functionality of the dugout pond at Danggra Bisik, and evaluated the growth and maintenance of the plantation at Dite. Additionally, the team visited Dollonggre village on the same day to engage in discussions with the Rongdenggre EC members. They addressed FMP-related matters, inspected the ongoing RCC check dam at Pagrang Chring, and assessed the progress of the dam with Storage Tank project at Apalgre Chimik.









On May 23,2023, AM & EE KM visited Tomonpo Anglong & Mawkangi Village under Umling C & RD Block to follow up on the Grassroots Innovation Fund and to prepare a Case study & Video Documention on Shri.H Khlein, the Innovator of Low cost Power Tiller & Threshing Machine.

DISTRICT WISE ACTIVITIES





On May 23rd and 24th, 2023, Ri-Bhoi DPMU and 14 VNRMCs completed a two-day internal audit. An audit is essential for assessing the effectiveness and efficiency of an organization's internal controls, risk management, and adherence to established procedures and regulations. Shri. Khokon Sadhukhan and Shri. Pratim Karmakar led the audit.



On May 22, 2023, the DPM of Ri-Bhoi DPMU observed and monitored the planning Department's CPR survey. The survey also involved the VCF's from the CLLM project.


On 23rd May 2023 first batch of orientation Program for PES beneficiaries phase II, was held at St. Vincent's Hall, Mawkyrwat Parish.

The VNRMC members provided assurance that they would rectify these issues promptly. Additionally, the follow-up also reviewing included the minutes register, purchase committee register, cheque issue register, training register, and GRM register.



Institute of Natural Resources (INR)

CENTRE FOR WATER RESOURCES





A collaborative site inspection was conducted at Laitryngew, involving the Director of the Institute of Natural Resources (INR) and the PHE Department, with the purpose of exploring potential convergence opportunities under MLAMP. Additionally, another inspection took place for Open Limestone Channel (OLC) at Laitryngew and Laitduh Village, led by the INR Director and Senior Manager of MLAMP. While conducting the site visit at Laitryngew, the INR director emphasized that "Acid Contaminated Water is now accessible to meet the drinking water needs in water-stressed regions, such as these areas. However, constant monitoring of the water quality is required."





A review meeting was conducted with the Spring Field Associates (SFA) for the project "Hydrological Spring Mapping in Meghalaya". The SFAs were assigned to each block in Garo Hills regions. Additionally Spring Verification was conducted in Chisim Rombagre and Bajengdoba North Garo Hills, with our GFA and village headman.

Inclusive Supply Chain & Enterprise Development





On 24th May 2023, a Multi-Stakeholders Platform (MSP) was conducted at Mawmaram cluster for the piggery value chain under Sohiong C&RD Block, EKH. Additionally, on 30th May 2023, another MSP was held by ISC&ED at Songsak, Mawshynrut C&RD Block, West Khasi Hills district.





Site inspections of Farmers Market along with the FFMC were conducted based on their respective Master Plans to assess project requirements. The inspections took place at Phlangwanbroi, Mawsynram Block, and at Kyrphei village, Mawphlang Block, East Khasi Hills District on 24th May 2023.

SPMU staff facilitated sessions on various subjects, including fund utilization, identification and selection of service providers, roles and responsibilities, and the formation of IVCS under Phase III. Group discussions and interactive sessions were held between the SPMU, DPMU team, and the Chairman and Secretaries of IVCS to foster engagement and collaboration.

RURAL FINANCE

An awareness program took place at Wahkaji Village, Ranikor C&RD Block, South West Khasi Hills, with 103 participants on 24th May 2023. Another program was held at Wahkdait Village and Umniuh Nongrim Village,Pynursla C&RD Block. Furthermore, a similar program was conducted at Dorambokgre, Rerapara Block, on 27th May 2023 and at Babelapara, Purakashia Block,South West Garo Hills on 29th May 2023.
