## WORLD BANK MISSION

Collaborating with Mynska Village Natural the Resource Management Committees, the team actively participated in tree planting activities and held meaningful discussions. Additionally, they had the privilege of meeting Kyrsiew Ryngkhlem, an inspirational figure in the field of organic farming, while conducting a comprehensive review of the progress made under the Meghalaya Community Led Landscape Management Project.

While the other team, comprising Pyush Dogra and Nitika Suri, visited Jakrem Presbyterian Upper Primary School. Witnessing the transformative power of community computers in teaching Natural Resource Management, the team observed firsthand the positive impact on the students. Engaging with the Pyndensakwang and Lawblei Village Natural Resource Management Committees (VNRMCs), the team fostered dialogue, actively participated in tree plantation initiatives, and reviewed the overall progress of sustainable practices and community engagement under the Meghalaya Community Led Landscape Management Project.

These visits and interactions provided the World Bank Mission team with valuable insights into the implementation and outcomes of the Meghalaya Community Led Landscape Management Project. The enthusiasm and dedication displayed by the communities, educators, and innovators further reinforced the project's significance in promoting sustainable practices and empowering local stakeholders.



## **DISTRICT WISE ACTIVITIES**



Ri-Bhoi



EE Accounts along with Environment Team and Field Engineer visited Belahari, Nongwah Mawlein and Umsong villages under Jirang C & RD Block to prepare the utilization certificate for FMP Implementation.

EE Accounts and Field Engineer visited Umdoh 18th Mile, a Village in the Umling C & RD Block, to prepare the Utilisation Certificate for FMP Implementation. The Utilisation Certificate gives a detailed account of how the allocated resources have been used and assesses whether they have been used efficiently and for the intended purposes.





On the 13th of June,2023, PA (Environment Management) followed up on the Natural Regeneration and Forest Management Plan intervention at Umsarang under Bhoirymbong Block and discovered that both were completed.

## **DISTRICT WISE ACTIVITIES**



On June 14, 2023, the field Engineer and PA(Environment) of Ri-Bhoi DPMU inspected the Forest Management Plan activity site at Belahari under Jirang Block and found the work status to be approximately 70% completed. They then visited the Interventions under Forest Management Plan at Umsong and Nongwah Mawlein under Jirang C & RD Block and discovered that the work status there was completed. The inspections showcased significant progress in implementing the Forest Management Plan, fostering a harmonious coexistence between human activities and the environment.



On June 6, 2023, Field Engineer and Shri H.K. Hajong, MCS officials of Soil and Water Conservation, visited as third party officials Darechikgre, Jengitchakgre, and Lower Dopgre in Gambegre Block for inspection of completed Project activities of Amrit Sarover taken under WDC - Soil and Water Conservation, HKKP, and MGNREGS. On the same day, they also visited Rengsipara and Sanjengpara villages in Dalu Block for the same purpose.

## **DISTRICT WISE ACTIVITIES**



On June 9th, 2023, Deputy Manager (EM), FE, PHE team visited Dorenggre VNRMC to inspect the CC Check dam of Tebilbal Chiring, which serves as the intake point for the upcoming JJM project at Dopanang Village. PHE (JJM) proposed raising the dam's height, providing soling on the pond, and fitting necessary pipes, while CLLMP suggested submitting their plan and estimate to the DPMU before proceeding. Additionally, DM-EM and FE visited a site undertaking FMP activities and guided VCFs on the correct process of Assisted Natural Regeneration (ANR).



On June 8, 2023, FE and External Expert-KM inspected ongoing CDF work in Damal Onthapara, Doldenggagre, and Darong Adu to ensure that the VNRMCs use proper grade materials and structure sizes as per CLLMP Estimates and Drawings.

On June 13th, 2023, the first day of training on Natural Farming took place at Bakripara Anganwadi Centre in Tilrikilla. The training was specifically designed for farmers from MegLIFE (JICA) villages under Tikrikilla Block. The resource person leading the training was from Bethany Society, in collaboration with CLLMP and MegLIFE. Assisting in the training was the CLLMP staff member, Asst. Manager-SM.

## **DISTRICT WISE ACTIVITIES**



Continuing on June 14th, the second day of the Natural Farming training was held for farmers of MegLIFE (JICA) under Tikrikilla Block. The training was organized by Bethany Society in collaboration with CLLMP and MegLIFE. Asst. Manager-SM from CLLMP actively participated in the training. Notably, the Director of Bethany Society and the Consultant of MegLIFE also made visits during the training session.

#### **COMMUNITY NURSERY**

433 Villages under MegLIFE Project have elected to set up community nurseries. Following the completion of preparation of nursery mother beds where seeds will be sown, communities are working on filling Polybags with potting material; a mix of soil, sand and compost (in prescribed proportion). Polybags are for transplanting the small seedlings from mother bed into a container for transportation to the planting site.

#### **CENTRE FOR WATER RESOURCES**

Almost 30 passionate farmers eagerly participated in this transformative training.
