DISTRICT WISE ACTIVITIES





DPM and FE visited Rohbah village to inspect the newly constructed Traditional Hall and Nursery, part of the Forest Management Plan. The hall is completed and will soon benefit the community. DPM also assigned VNRMC to oversee facility maintenance and highlighted the nursery's income potential for future plantation work.



DPM, DM-M&E, and FE visited Nongsynrieh village to meet with VNRMC members and discuss upgrading the ongoing footbridge construction project from a basic bridge to an arch bridge. This transformation aims to improve the bridge's aesthetics, turning it into an appealing tourist attraction for visitors to the village.

DISTRICT WISE ACTIVITIES



On September 14th, 2023, AM-SM and the Project Coordinator from School Net inspected KYAN Smart Computers at three schools. At Jingaiti Secondary School, ongoing construction delayed usage, with a commitment to use it soon. Nolikata Higher Secondary School faced an electricity issue and awaited a replacement UPS, also planning to use the kit as directed. Similarly, Indira Gandhi Memorial School had electricity problems, but the principal pledged to maximize kit usage.

On September 12th, 2023, AM-SM and the Project Coordinator from Schoolnet visited Sharak Rit Upper Primary School and Nongnah Def UPS at Nongnah. They found that the kit had been used sporadically. After discussions with the teachers and principals, they recommended regular kit usage for the of the benefit students and the community. The staff received additional training, and they now use the kit without difficulty. Teachers and principals of the schools were present during the visit.



DISTRICT WISE ACTIVITIES



West Jaintia Hills



On 14th September, GB meeting was held at Moopyllaitsyiar village in the presence of the DPMU team, EE, Headman, VRNMC, and the General members. The meeting was conducted to review the CNRMP activities, assess the FMP, balance funds, and discuss working schemes.



DPMU team along with Dr Wansa Pyrbot, Environment Manager, conducted a follow-up on the Forest Management Plan (FMP). They also assessed the forest's condition and reviewed the Annual Narrative Report (ANR).

GB meeting and awareness program held in Thadmuthlong village, where Dr. Wansa Pyrbot, Environment Manager, headmen, and the community members participated. During the meeting it was revealed that twenty-two project activities have already been completed.

West Garo Hills



A Block Level Review Meeting was held on September 14, 2023, at the Gambegre Block office in West Garo Hills District. It was attended by the VNRMC President, Secretary, and three Village Community facilitators. The purpose of block-level meetings is to assess progress, address pending activities, identify solutions, and areas for improvement. The team had an extensive discussion with VNRMC-EC members, focusing on various agenda items with actionable tasks to complete UC submissions by September 30, 2023.



On September 18th, 2023, Field Engineer visited Saka Boldamgre under Gambegre Block to provide instructions to the mason regarding the construction of a water reservoir and storage tank at Dobok Chiring and Songgital Gittim, as proposed under the Cluster Development Fund (CDF). Additionally, on the same day, there was an inspection of the Permanent Nursery establishment, during which the VNRMC EC members were instructed to adhere to the norms established by the DPMU office in West Garo Hills district.




A two-day training session on Bamboo Resource Assessment for VCFs in the Khasi-Jaintia Hills region was conducted on September 14th and 15th, 2023.





A field visit was conducted by the SPMU team and Bah Saphai, a resource person from Ginger Station, Umsning, for the Farmer Field School and training on ginger farming at Nonglang IVCS and Umthlu IVCS in West Khasi Hills District.

On September 14, 2023, a field demonstration was conducted to set up a demonstration plot and Farmer Field School in Mynsngat village, West Jaintia Hills.





In July and August 2023, a series of Multi-Stakeholder Platforms were held in West Jaintia Hills at Lakroh IVCS on July 28th, Lamin IVCS on August 3rd, and Jarain IVCS on August 23rd.

On September 14, 2023, a field visit was conducted in Nongrum Mawphlang to renovate damaged structures. Simultaneously, boundary mapping was carried out for field demonstration plots in Kyiem, Pyndenglitha, Mawlumrum, and Jabar Lumtop Jaud, situated in East Khasi Hills.
