## Meeting at Prime Hub Tura Discusses Carbon Financing in Garo Hills



On January 24, 2024, a meeting was held at Prime Hub Tura to talk about MRV (Measurement, Reporting, and Verification) in PES Ganol Catchment Villages and the Carbon Financing project in Garo Hills.

Dr. S. Ashutosh, along with other key people, led the meeting, which included discussions with experts from Shillong. They talked about how to measure and report environmental efforts and the plans for a project to finance activities that help reduce carbon emissions.

Later that day, the team visited Zikzak block to chat with the local community about Carbon Financing. They also organized a simple program to explain what Carbon Financing is and what its goals are. This is part of an effort to involve and inform the local residents about the project and its positive impact on the environment in Garo Hills.



On January 24th and 25th, 2024, KfW officials led by Mr. Ralph Lennertz and Dr. Brajesh Tiwari, visited Arbella Chidekgre, Chibasalgre, Dura Kalakgre, Matchurigre, and Bibragre Villages under Rongram Block and gathered vital information, focusing on social and environmental factors. This initiative aims to better understand and address community needs in the region.

### “General Meetings and Awareness Sessions across various Blocks for IVCS”



The IVCS general meeting for VPIC, organized by various Block Project Managers (BPMs), took place on January 24, 2024, in the villages of Gambaregre and Chibokgre within the Rongram Block, West Garo Hills District. Simseng Gading VPIC oversaw the gathering in Gambaregre, while Sagal Nokat led the session in Chibokgre. Concurrently, another meeting focusing on the establishment of IVCs and creating awareness at the cluster level occurred for Gindopara, Silsekgre, Chinapgre, Derikgre, Rencha Apal, and Dijingro Apal VPICs at Rencha Apal cluster hall, Rongram block, WGH. These VPICs were also provided with a flipchart on Plantation and Community Nursery.

On January 25, 2024, an awareness session regarding IVCS formation was conducted in the Chandigre cluster under Rongram block. The target audience included 5 village Nokmas, Secretaries, and VCFs. Villages like Sasatgre, Chandigre, Ading Nokat, Baladingre, and other non MegLIFE villages, already registered as Sasatgre Multipurpose dairy group, only required enhancements to strengthen their existing group. However, the combination of Bibragre and Tosekgre did not meet the criteria for forming an IVCS.

In the Resubelpara Block, a meeting for the establishment of IVCs was led by Kosichora VCF and Chairman. All attendees expressed their willingness to establish the IVCs.

### "Resubelpara Block Project Associate Curates Seeds for Gap Filling"



Resubelpara Block's Project Associate (PA) has just curated seeds of *Azadirachta indica*, *Terminalia belerica*, Jolpai, and Techri (*Tectomia japonica*) for gap filling.



Community nurseries have been set up in different Blocks across various villages, managed by VPICs, to grow plants for the upcoming year 2024 in specified plantation areas.

### Smart Solutions for Farmers: Arogyam's Soil Sathi Enhances Agricultural Practices



Soil and water testing of demonstration plots selected from each IVCS was conducted at Dadenggre, Selsella, and Tikrikilla, **West Garo Hills** from January 22 to January 27, 2024. Utilizing the innovative Soil Sathi Device with an inbuilt smartphone developed by Arogyam, macro and micro-nutrients present in the soil were analyzed. The device automatically recorded readings on the Arogyam website through network connectivity. The tests covered the presence of Nitrogen, Potassium, Phosphorus, Calcium, Zinc, Iron, Boron, Nitrate, and Ammonia in both water and soil samples. Certificates and detailed reports will be provided by the Arogyam Institute.

The event, facilitated by the ISC&ED Tikrikilla Block team, **West Garo Hills** and a Resource Person from SPMU under the MLAMP project of MBMA, aimed to enhance the knowledge of about 18 Service Providers on soil and water testing techniques.
