CM ELEVATE CONCLAVE 2024

The CM Elevate Conclave 2024, held on 12th March at U Soso Tham Auditorium, Shillong and 13th March at the District Auditorium, Tura, marks a significant step towards youth empowerment and entrepreneurship in Meghalaya. Under the visionary leadership of Chief Minister Shri. Conrad K. Sangma, various schemes and initiatives are being implemented to foster economic growth and development in the state.

Beneficiaries approved under schemes like the Meghalaya Agriculture Warehouse Scheme, Meghalaya Common Facility Center (CFC) Scheme, and newly appointed Village Data Volunteers (VDV) implemented by Meghalaya Basin Management Agency under the Meghalaya Livelihoods and Access to Markets Project (Megha-LAMP), were honoured to receive Sanctioned Letters for Funds and Appointment Letters from the Honorable Chief Minister of Meghalaya, Shri. Conrad K. Sangma. The sanction letters for funds and appointment letters distributed during the conclave highlight the government's commitment to empowering individuals, collectives, and traditional institutions.

In collaboration with both public and private banks, the Government of Meghalaya facilitates access to credit, thereby encouraging aspiring entrepreneurs to establish new ventures or expand existing ones. To mitigate financial risks associated with entrepreneurship, the government offers capital and operational subsidies, covering 35% to 75% of the project cost. Additionally, entrepreneurs benefit from handholding support such as training and capacity-building programs. Through a user-friendly single-window portal, entrepreneurs can seamlessly apply for various business ventures across sectors, thus fostering economic growth and development in the state.

At the recent program in Tura, 5 people received sanction letters for the Meghalaya Agriculture Warehouse Scheme, 6 were supported for the Meghalaya Common Facility Centre (CFC), and 184 individuals were offered appointment letters as Village Data Volunteers (VDV) by the Honorable Chief Minister of Meghalaya, Shri. Conrad K Sangma. These beneficiaries were carefully identified and selected as part of the Meghalaya Livelihood Access to Markets Project (Megha-LAMP). This initiative aims to uplift and empower the community by providing essential resources and opportunities for growth.





From 10th March to 13th March 2024, the IFAD team accompanied by the SPMU and DPMU team had a busy schedule, visiting various IVCS locations in Meghalaya. They started by engaging with members of Timsiminia IVCS Ltd. in Kharkutta,

NGH, followed by a visit to Rengsingpara IVCS Ltd. in West Garo Hills District. Led by Sir N Srinivasan, they interacted with MC members and local shopkeepers, inaugurated a Bakery unit, and visited an Arecanut Processing unit. They also observed activities at the MeghFarm and Prime Hub in Khamari, Tikrikilla.

Continuing their visits, on March 12th, the team went to SWGH and met members of Kentrikona IVCS Ltd. and Dondime IVCS Ltd. Later that day, they visited Dadenggre and interacted with Pringprang IVCS Ltd. and Chenggaldare IVCS Ltd. Then, on March 13th, they traveled to Rongjeng and engaged with Nongshram IVCS Ltd. Throughout these visits, each IVCS provided presentations and updates on their progress.

FIELD VISITS



On 6th March 2024, there was a field visit along with the ADB team and meeting with Laittyra IVCS Ltd., prior to that, on 7th March 2024, they went for a field visit to Diengkynthong Prime Hub and Diengkynthong Honey Processing Unit.





On 8th March 2024, an examination for the post of Village Data Volunteer (VDV) for Batch II & III was conducted across multiple districts including East Khasi Hills District, East Jaintia Hills District, and Ri Bhoi. In East Khasi Hills District, there were a total of 395 candidates registered, with 212 candidates appearing for the exam and 185 absent. Additionally, a session was held in Khliehriat, where 93 candidates participated.

FIELD VISITS





Right after their visit to the Garo hills region, the IFAD Mission team members continued with their visit to the Khasi and Jaintia region. On the 15th March 2024, the team visited Umkon IVCS Ltd., and Umshaken IVCS in Ri Bhoi District, interacted and discussed on matters relating to the IVCS, arecanut processing unit, PGs, NRM activities, the activities that can be taken up at the PRIME Hub, Umdihar Ltd. The IFAD Team was accompanied by the DPMU and SPMU team. On 16th March 2024 the team visited Pamtbuh IVCS, Nonglatem farmers market and Wahiajer IVCS Ltd., The team sat with the IVCS members, PG members, SPs, and discussed on matters related to the IVCS, CMC, CHC, PGs and NRM.

Updates from the IVCS Meeting at Nanil Apal Cluster



On March 6, 2024, a meeting took place at Nanil Apal Cluster, during which 50 promoters and 18 committee members were chosen, marking the completion of phase 3 for the Nanil Apal Community Nursery. Furthermore, on March 9, 2024, another meeting convened at Arengdo village, Kharkutta Block, with a focus on establishing an IVCS for Arengdo and Rangsa villages. Attendees discussed cluster plans and aimed to finalize resolutions and documents, including the details of 50 promoters, by the following week. The meeting also involved a site inspection for a proposed Community Hall construction in Arengdo village.

"MegLIFE Project Advances: Engaging with Communities and Securing Land for Planting"



The recent advancements of the MegLIFE project are highlighted by successful gatherings held on March 6, 2024, in Nolbari, Patijora,

Productive discussions also took place in Bolbokgre, Bolchugre, and Dambuk Atong, focusing on plantation areas within the Rongara Block.

and Hulubaripara villages, engaging with the Hajong Community. These meetings were made possible by the enthusiastic collaboration of the A'king Nokmas. Their gracious approval for land access for planting purposes has been secured, with the Nolbari VPIC allocating A visit to Rongkinggre VPIC on March 5 addressed concerns regarding future activities. Villages like Goramara, Bollongre, and Mangrugri are actively participating in the project, with VPICs offering land for planting activities, resulting in positive outcomes.



Community nurseries have been set up in different Blocks across various villages, managed by VPICs, to grow plants for the upcoming year 2024 in specified plantation areas.

Land Demarcation and Dispute Resolution in Rongram and Nayapara Villages



In Rongram Block, Renchagre VCF has demarcated 5 plots totaling 49.26 hectares, contributing to the total area demarcated by the VCF thus far, which stands at 93.84 hectares, with plans for further demarcation. Meanwhile, Rongram PAs are in the process of verifying 2024 plots in Anogre and Teksragre. In Nayapara Village, Tikrikilla Block, a meeting convened on March 6, 2024, addressed a land dispute concerning a 20-hectare area required for a project, attended by key stakeholders including Nokma representatives, DPM, BPM, and divisional officers. Despite previous disagreements, the Nayapara VPIC successfully identified a 20.03-hectare replacement area in March 2024. During a recent meeting, villagers expressed a willingness to reconsider the original disputed land, leading to further internal discussions. Presently, 20.03 hectares of land have been designated for plantation, with the Aking Nokma also agreeing to provide additional land for this purpose.

""Empowering Comilla Cotton Cultivation: Training Program in West Garo Hills""



in collaboration with ICAR-Central Institute for Cotton Nagpur, Maharashtra, the event attracted Research, esteemed guests including Mrs. Malika R. Marak, Block Project Manager of Rongram, MegLIFE JICA West Garo Hills Meghalaya, Netjen Sangma, the village head, and Winath Sangma, Village Secretary. 49 farmers actively participated, sharing insights and experiences on Comilla cotton cultivation. Dr. H.G. Kencharaddi presented on "An Overview of the Project and Approaches to Enhance Comilla Cotton through Participatory Breeding in Jhum Cultivation," stressing crop diversification and germplasm preservation. Dr. Rikey Thokchom discussed "Establishing Market Linkages between Comilla Cotton and the Surgical Industry." The event facilitated interactions between scientists and farmers, fostering valuable exchange of cultivation techniques. Essential resources including stainless steel buckets, Comilla cotton seeds, and vegetable garden kits were distributed to support farmers' practices as part of the project objectives

On March 7th, 2024, a significant training program on "Enhanced Cultivation Techniques and Participatory Plant Breeding Methods for Comilla Cotton" was held in Chibokgre village, West Garo Hills, Meghalaya. Organized by the Multi-Technology Testing Centre and Vocational Training Centre at the College of Community Science (CAU--Imphal), Tura, Meghalaya,.

Stephenson G Momin, a 69-year-old retired forester currently working as a Project Associate for MegLIFE under Songsak C&RD Block, is actively involved in seed collection for community nurseries in various villages. He has gathered seeds according to the seed calendar from several locations including Nengkra, Samgong, Akelgre villages, and Rongrenggiri Forest reserve. Species like Chandan, Terminalia chebula, Melia azadirach, Lagerstroemia speciosa, Cassia fistula, Tamarind, Gmelina arborea, Terminalia arjuna, among others, have been collected to improve and expand existing community nurseries. Stephenson goes above and beyond by personally contributing extra seeds for the enhancement of these nurseries, showcasing his dedication and hard work towards the project

a pivotal workshop titled "Geo-Spatial Applications for Natural Resource Management (NRM) and Land Use Land Cover (LULC) Change Analysis in Meghalaya" was held at the Don Bosco Youth Centre in Shillong. The event saw the participation of esteemed Chief Guest Dr. S.P. Agarwal from the North Eastern Space Applications Centre, Government of India, Umiam, along with other notable dignitaries.

Throughout the day, participants engaged in in-depth discussions on various critical topics, ranging from analyzing spatial and temporal changes in surface water area to linking geo-spatial data for urban sustainability. Land use/land cover mapping and GIS applications in bamboo resource assessment were also key focal points. Moreover, insights into UAV applications for State Projects & Departments under the Government of Meghalaya were shared and explored.

The workshop provided a platform for experts and stakeholders to



exchange ideas and strategies concerning the optimal utilization of geo-spatial technology for effective natural resource management in Meghalaya. It served as a forum for understanding the challenges and opportunities presented by evolving land use patterns and environmental changes in the region.

The day culminated in a stimulating panel discussion, where participants deliberated on the insights gained throughout the workshop and explored potential pathways for integrating geo-spatial applications into sustainable development initiatives in Meghalaya. This workshop underscores the growing significance of leveraging advanced technologies such as geo-spatial analysis in addressing the complex challenges of natural resource management and land use planning, particularly in ecologically diverse regions like Meghalaya.



Payment for Ecosystem Services (PES)



"Empowering Communities Through MRV Trainings and

Surveys: A Journey of Learning"







MRV activities were conducted across various Blocks and villages, including Tongseng Village in VCF Lekibha Malang, Rongrikimgre Village in Chokpot Block, focusing Umniangriang Village on individual forests, Umwai Village, Aminda Rangsa Village under Gambegre Block, Nongkyndah Village, and Mawlongbah Village. These activities likely involved Monitoring, Reporting, and Verification related processes to forestry and environmental conservation efforts, aiming to assess and document the status and progress of forest resources and conservation initiatives in these areas.

Measurement, Reporting, and Verification (MRV) is a process of PES_GREEN Meghalaya conducted to assess the performance of the beneficiaries' activities as outlined in the scheme, through this process the quantum of next installment under the PES Scheme can be determined. MRV has been carried out for 381 communities only, that received funding for Year 1 in December 2022. Out of these, 324 communities have been selected to receive funds for the Second Year.

The MRV activity for 381 communities commenced on February 5, 2024, led by GREEN Field Associates at Block Level in collaboration with Village Community Facilitators (VCF), and completed on February 17, 2024.
