#### Recent Demonstrations of Half-Moon Terracing Techniques





Various demonstrations of half-moon terracing techniques were conducted across different villages recently. These demonstrations included the use of boulders in Borogobol village, bamboo in Anogre Rongram village, and another session in Abendagre Village. These activities aimed to showcase effective terracing methods to members of various (VPIC) and were facilitated by field experts.





Preparations are in progress in Golmangre, Betasing Block, as part of the SWGH initiative. Field engineers have recently assessed the spring tapped chamber in Nepalgre village, Betasing Block, SWGH. On April 22, 2024, the field engineers, alongside the GIS team and

the spring shed management team, carried out Spring Mapping in Imsambal village, Kharkutta Block.



Community nurseries have been set up in different Blocks across various villages, managed by VPICs, to grow plants for the upcoming year 2024 in specified plantation areas.

## MLSC Team Leads Successful Springshed Management Training in Block-Thadlaskein"



On April 22, 2024, the MLSC team conducted a training session in Block-Thadlaskein focused on springshed management, attended by 14 participants from Shiabnai VPIC. Villagers were taught hands-on techniques for evaluating crucial springs, leading to their successful restoration of one such spring. Additionally, they gained insight into water quality assessment through the team's physical tests, expressing satisfaction with their newfound knowledge.

#### "Educational Initiative on Medicinal and Aromatic Plants in Kharkutta Block"



An awareness program on the popularization of medicinal and aromatic plants (MAPs) was conducted for the MegLIFE project villages in Kharkutta Block. Ms. Easterlina M Sangma from Aroma Mission (INR) led the session, emphasizing the significance of aromatic plants, particularly Patchouli and lemongrass, which are well-suited for the Kharkutta region. Participants were informed that they could cultivate these plants in their plantation sites established through the MegLIFE project or in their individual plots, potentially earning a livelihood by processing essential oils. The session included discussions on the flexible demand and pricing of these plants, with lemongrass priced at Rs. 1200/- per kg/litre and patchouli ranging from Rs. 3000/- to Rs. 3500/- per kg. Attendees expressed interest and engaged in an interactive session.

On April 23, 2024, a meeting was held at Pringprang IVCS, Romgre, West Garo Hills, bringing together members of IVCS and officials from MLAMP. This gathering was part of the continuing exposure trip for IGA staff to IVCS facilitated by MLAMP.

On April 16 th 2024, MegARISE Staff of Ganol and Umiew Catchment, along with SPMU team, received comprehensive Training on Free Prior Informed Consent (FPIC) and Financial Participatory Approach (FPA) Guidelines at MegARISE Conference Hall, SPMU, Shillong. Mr Steffen Schuelein & Mr Nand Kishore Agrawal- Implementation Consultant (IC) DFS collectively took the session covering the objectives of FPIC, checklist, series of FPIC approaches, objectives of FPA, stakeholder views of FPA, the 8 principles of FPA, FPA Process, Contest 1,2 & 3 etc. Meanwhile a very short presentation of Nagaland exposure visits were shared by both SPMU and CMU team



At the MegARISE Office on Springside Road, Nongthymmai, a comprehensive Management Information Systems (MIS) training session was conducted for the staff. The primary objective of this training was to bolster the team's grasp and proficiency in leveraging information systems to streamline operational processes.

#### Trainings conducted



MSRLS conducts Five-Day Training for Krishi Sakhi on Natural Farming at BMMU Wapung, EJHD

During the training, participants engaged in both theoretical and practical sessions covering key aspects of natural farming. The sessions included an introduction to natural farming principles and their importance, soil health management covering soil types, nutrients, and the significance of Soil Health Cards. Participants learned to prepare bio-stimulants like Jeevamrit, Beejamrith, and Ghana Jeevamrit Drava, and explored pest and disease management techniques using remedies such as Brahmastra, Neemastra, and Agni Namastra.

The training continued with practical demonstrations on water management techniques like rainwater harvesting and mulching, insights into integrated farming systems, discussions on health and nutrition in Nutri-Kitchen Gardens, seed selection, planting methods, and cropping patterns for natural farming. Additionally, participants received information on extension methods like Farmer Field Schools (FFS) and were briefed on agriculture finance tools including the Kisan Credit Card (KCC), PMFBY (Pradhan Mantri Fasal Bima Yojana), Pig Insurance, and the certification and marketing of natural produce (PE-Farm).

MSRLS conducts Training for Krishi Sakhis Certification on Natural farming MSRLS conducted a certification training on Natural Farming for Krishi Sakhis at two clusters (Nangbah & Wahiajer) covering four villages (Myrjai, Mupliang, Nartiang & Phlongingkhaw) under Thadlaskein, West Jaintia Hills District.



The training aimed to equip Krishi Sakhis with essential knowledge and practical skills in natural farming techniques to enhance sustainability and productivity in agricultural practices within the targeted villages.

During the training, participants were introduced to the concept of Ecosystem Services and the principles of Natural Farming. They learned about livestock integration techniques, pest & disease management strategies, and the preparation and application of biostimulants & bioextracts through theoretical and practical sessions. The training also covered essential aspects of water management in agriculture, emphasizing efficient use and conservation practices tailored to local conditions and needs.

Such endeavors not only hold promise for economic empowerment but also underline the importance of community engagement in fostering environmental stewardship and socio-economic progress.
