Update on Field Operations Across Multiple Sites"



Advance work is underway at Dotrongre supervised by Assistant Manager Tikrikilla. On April 23, Manggakgre and Tosekgre, Rongram also began their advance work. Jungle clearance for agroforestry started at Rangtapgre VPIC on April 25. This work is happening at various locations including Lower Sari Awe Village, Chibrajambal Village, and Belguri VPIC. Fencing preparations at Derikgre Rongram and bamboo staking at Daljagre Rongram are ongoing. Nursery activities are progressing at Rongpetchi VPIC and Abendagre Village. Jungle clearance is ongoing at locations like Malchapara village and Simseng Bolma. Stake placement for agroforestry plots has begun at Sasatgre Rongram and other location.

"Spring Shed Management Survey Highlights"



Field survey for spring shed management conducted with MLSC Team. In Kharkutta Block NGH, the team completed the 2nd village training on spring shed management at Mynkrem village. The session involved discussions on spring sources, challenges, number of springs available, benefits, active committees, intervention sites, and selection criteria. In Asil Songgital under Songsak Block, community interaction and the first day of field visit with MLSC team and Master Trainers occurred, focusing on identifying critical springs. At Nokatgre, spring testing for domestic use was conducted. In Demthring VPIC, a field survey for spring shed management took place with 22 participants, led by MLSC and SPMU teams. A similar survey occurred in Resubelpara Block at Nokatgre village. In Vill.

Rongpetchi, spring tests were conducted with the MLSC team. The survey extended to Galwangitok VPIC in Gasuapara Block and VPIC Ionglang in Laskein Block, aiming to assess spring shed management alongside MLSC and SPMU teams



Community nurseries have been set up in different Blocks across various villages, managed by VPICs, to grow plants for the upcoming year 2024 in specified plantation areas.

On April 24, 2024, the Block Program Manager (BPM) of Chokpot visited Rongma village to discuss the conversion of Jhum plots to Agroforestry plots. The community has consented to allocate 26 hectares of land from 15 individual households for this purpose. Fencing, cleaning, and preliminary work are scheduled to be finished by the first week of May 2024.

"Community Visit: Bench Terracing and RCC Tank Construction"



On April 25, 2024, the Field Engineer (FE), along MTA and the Assistant Manager of Resubelpara Block, paid a visit to Rongpetchi and Nokatgre villages. Their agenda included demonstrating bench terracing techniques and conducting measurements for the construction of an RCC tank at the Community Hall. Meanwhile, progress continued on the Plastic Tank Platform project in Nepalgre village, Betasing Block, South West Garo Hills. Additionally, a team of officials inspected various springs in Galwangitok village, Gasuapara Block, South Garo Hills, accompanied by the MLSC team, Geographic Information Systems (GIS) experts, and a Master Trainer. Their objectives encompassed evaluating water quality, monitoring water discharge rates, and other pertinent parameters.

MegARISE project staff went on field immersion to MegLIFE villages from April 29th to May 5th 2024. These visits included meetings with District Project Managers (DPM) and Block Project Managers (BPM), alongside stakeholders from MegLIFE and local district administrations.

Participants explored individual nurseries, villages, and project sites, witnessing initiatives such as community nurseries, plantation sites, training halls, fencing, and spring developments. They interacted with Village Project Implementation Committee (VPIC) members, discussing project objectives, strategies, and the importance of sustainable land management.

Throughout the immersion, the emphasis remained on collaborative efforts between stakeholders, sustainable practices, and community empowerment. These visits provided valuable insights into ongoing efforts to promote rural development and environmental stewardship in Meghalaya under the MegARISE project.

"Forest Protection Efforts: Fireline Setup & Boundary Work in various Block"



Boundary demarcation and forest fire line activities at Meka Adu Community Reserve in Gasuapara block. Forest fire line activities were also conducted by Molmigre Community in SHG Gasuapara block, and work commenced by Wilnak Marak from Rondupara under Dadenggre block. Chiresil Marak's RF in Agonggre began forest protection efforts and installed sign boards. Additionally, Damdiloka PES under Zikzak Block and Jangnapara in Betasing block (SWGH) carried out forest fire control and prevention activities. Site visits were conducted by Green Field Associates (GFA) to discuss PES activities, including UC collections and monitoring of other PES activities in the area.

On May 1st, 2024, marked a significant milestone at the Mawlong Nongtluh site in the Umling C&RD Block, Ri Bhoi, as the installation of the Fractional Distillation Unit (FDU) was successfully completed. Following meticulous installation, the unit underwent rigorous trial runs, showcasing promising results with a 1% recovery yield of essential oil. Meanwhile, efforts extended to Pamlaban, Umsning C&RD Block, Ri Bhoi, where preparations for the installation of another FDU were underway,

In a collaborative effort to empower local communities and promote women's health and hygiene, a capacity-building session was organized for Dabram IVCS at Baghmara. The focus of the training revolved around the formulation and production of Medicated Sanitary Napkins, a critical aspect in ensuring menstrual hygiene management. Facilitated by experts from CSIR-CIMAP Lucknow, participants were equipped with essential knowledge and skills necessary for initiating sanitary napkin production. This initiative not only underscores the importance of local empowerment but also highlights the synergy between grassroots organizations and scientific institutions in driving positive social impact.
