Enhancing Community Empowerment through Capacity Building



A one-day training on dry rations was conducted on 23rd May 2024, at Mawphlang C & RD Block. The training was intended for the IVCS, Service Providers (SPs), progressive farmers of the Veterinary Department, Piggery Mission availing Society, and FOCUS progressive PGs. The event was represented by Smt. V. Waanbah (AE), EARMAC resource person, and the Chairman of the Mawphlang EFC Team.

Bookkeeping training and concept seeding was conducted for Group Facilitators, FOCUS Facilitators, and NGO Partners of South West Garo Hills on May 23, 2024, at the Additional DC Office Building in Ampati, SWGH. Following the training, participants left equipped with knowledge of PG Bookkeeping, UC Collection, and the selection of the best PG from their respective blocks.

On 23rd May 2024, a one-day training session on PGs bookkeeping for FOCUS Facilitators from both Mawkyrwat and Ranikor C & RD Block was conducted in the presence of Ms. Evanisha Pathaw, Manager, FOCUS, SPMU. The training was held at PHE Hall, Mawkyrwat, SWKHD, and had a total of 33 participants. Activities included concept seeding by Evanisha Pathaw and bookkeeping training led by Shanbor Marngar, CM.

The concept of CHC was well received by the IVCS and their members, and they look forward to setting up the CHCs in their respective IVCS.



Dry Ration Training for IVCS and SPs in the value chain (piggery) was held at EFC Khatarshnong Laitkroh C&RD Block on 27th May 2024, where Dr. S. Lyngri and Dr. M. Shylla from the Veterinary Department, along with Mr. M. Thabah, Chairman of EARMACS, served as the Resource Persons.







A three-day hands-on training program was conducted for the women members of Rongara Agro Food Processing Cooperative Society at Rongara Prime Hub, South Garo Hills. During the training, the participants were taught minimal processing and preparation of value-added products from raw jackfruit on a commercial scale. Twenty women successfully participated in the training.

A Block Level Review Meeting cum Credit Linkage Orientation Programme was held for the IVCS President, Secretary, Group Facilitators, Service Provider Credit Linkage, IVCS Managers, and Finance Committee members under Dadenggre Block, WGH, at Songadinggre LP School. The session focused on discussions and briefings regarding various aspects, including IVCS loan overdue, strategies for loan recovery, setting up repayment schedules, the role of Service Provider Credit Linkage, and targets for credit linkages such as IVCS loans to members, loans for individual IVCS members, KCC loans, and Bulk loans. The meeting saw active participation from IVCS members, and it concluded with unanimous agreement to collaborate for the enhancement of their IVCS.



A meeting was held with the Sub Registrar of Cooperative Societies, Smt. B. Pathaw (SRCS), Sohra Sub Division, along with the DPM, to discuss the status of the audit of the IVCS under Khatarshnong Laitkroh and Shella Bholaganj C&RD blocks. MegLIFE Project: Empowering Women and Minorities through Employment in Betasing Block



The MegLIFE Project, funded by the Japan International Cooperation Agency, emphasizes the inclusion of minority groups and all genders in its execution. This dedication is particularly visible in Malchapara and Kolkatola villages in Betasing Block, where over 20 women have been employed in daily wage work for tasks such as staking and pit digging as part of the plantation activities. These small steps towards inclusion illustrate that social change is possible with gradual progress.





A meeting with VPIC members and the GB was held by the BPM on May 27, 2024, to discuss gap filling, following the burning of half of their Community Reserve by hunters. During the meeting, the importance of fostering a sense of ownership for the project was emphasized, as many villagers believed it was solely the responsibility of the VPICs.

Green Field Associates (GFAs) are presently in the process of collecting application forms and utilization certificates, demonstrating their active involvement in gathering comprehensive information from applicants.





Forest fire prevention and control measures are underway in Rimtangpara village as part of the Payment for Ecosystem Services (PES) program. Beneficiaries from Sadolpara village have begun implementing initiatives such as constructing staggered trenches, aiding in the natural regrowth of plants, and erecting boundary pillars. Additionally, fencing has been completed around the Ganipara PES reserve. Meetings are underway with beneficiaries of the payment for ecosystem services scheme. The sessions encompass guidance on effective fund utilization and timely submission of Utilization Certificates (UC).
